- I. **CALL TO ORDER**: The Regular meeting of the Board of Education was called to order at 7:10 p.m. by Board President, Dave Hazekamp.
- II. **ROLL CALL**: Present Elroy Buckner, Kris Cole, Susan Franklin, Dave Hazekamp, Steve Kelly, and JB Meeuwenberg; Absent Tim Burgess.

III. APPROVAL OF AGENDA

IV. PRESENTATIONS:

- a. <u>School Board Recognition Month</u>: Each Board member was provided with a certificate of recognition from the Michigan Association of School Boards, and a special dessert was prepared and served to Board members from staff member Pam Gustafson. Board members received some Fruitport gear, and discussion pertaining to the annual framed art recognition was discussed. This was done in recognition of School Board Member Appreciation Month.
- b. <u>2023-2024 General Fund/School Service Fund Budget Amendment</u>: Mark Mesbergen presented a mid-year budget amendment for the General Fund and the School Service Fund to the Board of Education for their consideration.

V. COMMUNICATIONS:

OK Conference Communication - Dated: December 21, 2023

The Board reviewed a communication from the OK Conference that was received by the District on December 21, 2023. This communication denied a petition by Caledonia Schools seeking to vacate the recent realignment of the OK Conference.

• Thrun Law Firm Communication: New Attorney Contact

The Board reviewed a communication from Thrun Law Firm regarding a new attorney contact that the District will be working with at the Firm. The shareholder that the District has worked with is moving to "Of Counsel" status, so the District will be working with another shareholder within the firm, effective January 1, 2024.

VI. SUPERINTENDENT/ADMINISTRATIVE REPORTS:

- Review of Muskegon County School Report Card Data: The Superintendent reviewed recently released school report cards for each of the District schools in comparison to schools across Muskegon County with the Board. A spreadsheet was provided to the Committee that included grades, Reward School status, graduation rates, attendance rates, and peer comparison data.
- Alternative and Adult Education Graduation Requirements: The Superintendent reviewed a proposal from the Instructional Council with the Board to consider reducing the number of credits required for graduation from the Alternative and Adult Education programs from 22 credits to the State mandated 18 credit minimum requirement. All core course credits will still be required and a formal proposal will be forthcoming to the Board for consideration.
- **Strategic Plan Draft Review:** An updated draft of the strategic plan was reviewed with the Board. This will be further reviewed by the Board at the February 2024 Board meeting and considered for approval then.
- National AASA Conference on Education San Diego, CA: The
 Superintendent shared that he will be attending the AASA National Conference
 on Education in San Diego, CA in February. The Superintendent is an Executive
 Board Member of the Michigan Associations of Superintendents and
 Administrators (MASA). Airfare, hotel costs, and meals will be covered by

• Pam Gustafson was in attendance at the meeting and shared a special thank you with the Board of Education for their service to students, staff, and the community. Pam made a special homemade dessert for the Board in recognition of School Board Recognition Month. Pam also shared that she believes the Chromebook situation that she spoke with the Board on months ago has not gotten better at the middle school. Some staff members want to see Chromebook carts added back to the classrooms, while others do not. Pam personally believes that the middle school students are not responsible enough to care for the Chromebooks when they take them home, and that Chromebooks should stay at school for middle school students.

A special meeting of the Board of Education (the "Board") was held in the Board of Education Room at 3255 E. Pontaluna Rd., Fruitport, MI 49444, within the boundaries of the District, on the 19th day of February, 2024, at 6:30 o'clock in the p.m. (the "Meeting").

WHEREAS:

- 1. The administration has recommended that, pursuant to Board of Education Policy, and the Student Code of Conduct, a student whose identity is known to the Board (the "Student") be expelled for making a threat to commit an act of violence against a school employee and students, as well as for sexual exposure of the student's genitals toward students of the opposite gender.
- 2. School administrators notified the Student's parent/guardian of the specific charge underlying the disciplinary recommendation, as well as the date, time, and place of the disciplinary hearing.
- 3. Pursuant to the request of the Student's parent/guardian, and as authorized by Michigan Open Meetings Act Section 8(1)(b), MCL 15.268(1)(b), the disciplinary hearing was conducted in a(n) open/closed session meeting of the Board.
- 4. The hearing afforded the Student and the Student's representatives an opportunity to respond to the charge and to present pertinent evidence for the Board's consideration.
- 5. The Board has carefully considered all of the evidence produced in this student discipline hearing.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. A preponderance of the evidence established that the Student did commit an act of making a threat of violence against committed a school employee and students. A preponderance of the evidence also established that the Student did commit an act of

sexual exposure toward other students on school property in violation of the Student Code of Conduct.

- 2. Based on careful consideration of all of the following factors, the Board determines that expulsion is warranted:
 - The Student's age;
 - The Student's disciplinary history;
 - Whether the Student has a disability;
 - The seriousness of the behavior;
 - Whether the behavior posed a safety risk;
 - Whether restorative practices are a better option; and
 - Whether lesser interventions would address the behavior.
 - 3. The Student is permanently expelled from the District.
- 4. During the time of the expulsion, the Student may not be on school grounds or attend any functions at the District without prior written approval from an appropriate administrator.
- 5. The Student may petition the Board for reinstatement no sooner than 150 school days from the date of expulsion. Before reinstatement, the Student must do all of the following:
 - demonstrate successful participation in an appropriate counseling program approved by the Middle School Principal that includes both group and individual counseling;
 - Submit to the Middle School Principal competent and credible evidence from an appropriately licensed and credentialed professional that the Student does not pose a risk of harm to the Student or to others;

 - □ complete to the satisfaction of the Board all recommendations contained in any psychological or counseling report;
 - □ demonstrate to the satisfaction of the Board that the Student received educational instruction and cooperatively participated in an educational program during the period of expulsion;
- 6. Consistent with the Revised School Code, Board of Education policy, and the Student Code of Conduct, the Board finds that the interests of the District are served by this resolution.

- 7. Consistent with the Board's actions taken this date, administration shall promptly meet with the Student's parent/guardian to determine if there are appropriate educational services to which the Student may be entitled under state and federal law.
- 8. Administrators are directed and authorized to implement all terms of this resolution and are delegated all necessary authority to do so.
- 9. All resolutions and parts of resolutions insofar as they conflict with provisions of this resolution be and the same are hereby rescinded.

Based on a thorough investigation, the District's administration has concluded that your child, violated Board of Education Policy along with the Middle School Student Code of Conduct by making an intentional threat to commit an act of violence against a school employee or students. It was also concluded that your child committed an act of sexual harassment toward another student while at school. As a result, the administration has referred this matter to the District's Board of Education.

A hearing has been scheduled on Monday, February 19, 2024 at 6:30 p.m, in the Boardroom, which is located at the west end of Edgewood Elementary School at 3255 Pontaluna Road. Following the hearing, the Board will make a final decision whether to suspend or expel from Fruitport Community Schools. At the hearing, you, and his father, may submit evidence and present testimony to challenge the administration's findings or disciplinary recommendation.

You have the right pursuant to both Policy 2501 and Open Meetings Act Section 8(b) to have the Board hold the hearing in private (i.e., in a closed session of the Board), but as also required by law and policy, the Board must act on the matter publicly (i.e., in open session). If you want the Board to hold the hearing in private, the District will not disclose any personally identifiable information in open session when it acts. Please notify me as soon as possible whether you would like the Board to proceed in open or closed session. A copy of the hearing procedures is attached, as is a form that can be signed to hold the meeting in closed session.

Until the Board issues its final decision, will remain suspended from school, may not attend classes or other school functions, may not be present on school property, and may not participate in extracurricular activities. 5206-F-19 Due Process - Hearing Rights and Procedures

Right to a Hearing

Before a student is suspended from school for more than 10 school days or is expelled from school, the student has a right to a hearing. The Superintendent conducts hearings for students who have committed an offense that may result in suspension of less than 60 school days. A removal from school for 60 or more school days is an expulsion. The Board conducts hearings for students who have committed an offense that may result in expulsion.

What is a Hearing?

If, after investigating student misconduct, a school administrator determines that a student engaged in misconduct that should result in either a suspension of more than 10 school days or an expulsion, the administrator will refer the matter to either the Superintendent or the Board. Either the Superintendent or the Board will conduct a due process hearing to determine: (1) whether the alleged misconduct occurred, and (2) if so, the appropriate consequence.

The student and his or her parent/guardian will be notified in writing at least 3 calendar days before the hearing. The notice will include: (1) a description of the alleged misconduct; (2) the potential disciplinary consequences that may be imposed; (3) the date, time, and location of the hearing; and (4) an invitation to the student and his or her parent/guardian to attend and participate in the hearing.

During the hearing, school administrators will describe the alleged misconduct and explain the facts related to the misconduct. The student and his or her parent/guardian may present evidence and witnesses to demonstrate that the student did not engage in the alleged misconduct or that suspension or expulsion is not the appropriate consequence. The student and his or her parent/guardian may also present evidence of any mitigating factors that the Superintendent or the Board should consider. The student and his or her parent/guardian may be represented by an attorney or another adult advocate at their cost.

Although the student and his or her parents/guardians are entitled to due process, a student discipline hearing is not a "trial." The student and his or her parent/guardian do not have the right to compel attendance of witnesses or to "cross examine" witnesses. Typical rules of evidence are not followed. A student's refusal to answer a question or failure to attend a hearing may be considered by the Superintendent or the Board.

Superintendent Hearing

If, following an investigation, a student is recommended for suspension for more than 10 school days but fewer than 60 school days, the Superintendent will conduct the

hearing. At least 3 calendar days before the hearing, the Superintendent will provide the student and his or her parent/guardian the written notice described above.

The Superintendent will not suspend the student unless, after the completion of the hearing, the Superintendent is convinced, based on a preponderance of the evidence, that the student committed a violation of the Student Code of Conduct and that, after considering all legally required factors, suspension is the appropriate consequence. The Superintendent will provide written notice of the decision to the student and parent/guardian.

Board Hearing

If, following an investigation, a student is recommended for expulsion, the Board will conduct the hearing. Only the Board may expel a student.

At least 3 calendar days before the Board hearing, the Superintendent or designee will provide the student and his or her parent/guardian the written notice described above.

The hearing will take place at a regular or special Board meeting. The student and his or her parent/guardian may request that deliberations be held in closed session pursuant to Michigan Open Meetings Act section 8(b). The student and his or her parent/guardian must notify the Superintendent before the hearing to request that the deliberations occur in closed session.

The Board will not expel the student unless, after the completion of the hearing, a majority of the Board members are convinced, based on a preponderance of the evidence, that the student committed a violation of the Student Code of Conduct or an offense requiring suspension or expulsion under the Revised School Code and that, after considering all legally required factors, suspension or expulsion is the appropriate consequence. The Superintendent or designee will provide written notification of the Board's decision to the student and his or her parent/guardian. The Board's decision is final.

Students with Disabilities

Suspension or expulsion of a student with a disability is subject to the rights and procedures guaranteed by state and federal law. Except as otherwise authorized by law, a student with a disability may not be suspended for more than 10 consecutive school days or expelled for conduct that is a manifestation of the student's disability.
